These Quandts have a well-published and dubious past. Look at how these privileged corporations profited from the holocaust; even saving BMW from bankruptcy. Recall that Bavarian Motor Works was within a Prussian occupied area in the 1800s. The Kingdom of Bavaria was a German state that succeeded the former Electorate of Bavaria in 1805 and continued to exist until 1918.

The media actually did expose these Quandts between 2007-2011, however many of these articles no longer exist and the family remains silent; free to do as they will. They remain immune from the standards of accountability that any normal citizen would be subject to. The archives on the family still remain sealed.

Welcome to the face of the reinvented Prussian army within global Corporations. Prussia is now an idea. BMW



The Quandt family – Germany's richest– is a major shareholder of the German automobile manufacturer BMW. It made its fortune during the Second World War through the Nazi war machine, profiting from the forced labor of thousands at concentration camps.

During World War II, the BMW workforce was made up of slave laborers provided by the Nazis. Some sources put the figures as high as 50,000 forced civilian laborers, prisoners of war and concentration camp workers .

In 1943, with direct support from the SS, the Quandts were able to establish a company-owned concentration camp directly alongside their battery works in Hanover. KZ (Concentration Camp) Hanover, a satellite of KZ Neuengamme, exploited the labour of both Jews and resistance fighters, as well as forced labour from France and Czechoslovakia. Prisoners from the KZ Neuengamme were selected for hard labour at the Quandt battery works.

BMW was then owned by Günther Quandt, and he and his son Herbert were intimately connected with Hitler and his regime. BMW's factories exclusively produced aircraft and motorcycle parts for the Nazi war effort. In fact, many inmates were put to work on the Luftwaffe engines, namely the BMW 132. The Quandts also benefited greatly from the eradication of Jews and their livelihoods—they were handed multiple businesses seized from enslaved Jews.

Günther Quandt rose under the Nazis to become one of the biggest arms tycoons. His batteries were a significant component in numerous military vehicles and weapons. The AFA works supplied the main batteries for submarines and the long-range V2 rocket during the war. Other industrial companies that belonged to the Quandts included DWM (German Weapons and Munitions Factory). In 1937, Günther Quandt was appointed the "War Economy Führer."

Karl Friedrich studied business administration at the [University of Fribourg](#), Switzerland.

He is the chairman and sole owner of *Unternehmensgruppe Fürst von Hohenzollern* (Corporate Group Prince of Hohenzollern),^[1] including real estate and forests with 400 employees, and owns a 50% share in the *Zollern GmbH und Co. KG* (steelworks, transmission technics) with 2800 employees. The Prince himself is voice, saxophonist and leader of the music band Royal Groovin'.

He has been a member of the Advisory Board of [Südwestbank](#), a member of the Advisory Board of [Landesbank Baden-Württemberg](#) (LBBW) since 2007 and a member of the Southwest Regional Advisory Board of [Commerzbank](#) since 2008.^{[2][3]}

According to the suspended 1938 Constitution of Romania, Karl Friedrich is heir to the throne since 2017, upon the death of former King [Michael](#). However, in a 2009 interview, he stated that he had no interest in the defunct Romanian throne.^[4]

The meaning of the name Friedrich is "peaceful ruler". Think mirror.

It is intriguing that he rose to the throne of his House, at a time where wars would end with one final war between Russia and the USA (thanks to the Uranium 1 scandal) and then the New World Order would emerge.
