We finished Part 1 considering the possibility that Rockefeller henchman, John McCloy, possibly played a role in rebuilding the “*council of the gods*”.

In [Urania - Part 4](#), we introduced the ‘Osenberg List’ which recorded the names of the scientists that arrived in America as part of Operation Paperclip.

All Hands on Deck

This 1951 telegram highlights the coordination taking place behind Operation Paperclip. For reference, HICOG refers to the ‘High Commissioner for Germany’, an office which was held by John McCloy, during this critical transition period:

For Helen Hanson: HICOG personnel previously surveyed European equipment. Strongly recommend shipment from US as equip is difficult to obtain and film is poor quality.

For Moss: Equipment arrived 10 May '51.

For Becker: Request reply soonest possible re procedure to be used for purchasing books, etc., located in various small ref libraries. If State is to be used, request name of HICOG contact.

For Marsten: Coordinating with HICOG records management personnel re disposition of various files of interest to agency. Mutual program being arranged. Request any instrs re procedure required Stateside.

For Hutzel: Six cases Osenberg files from Norstrom currently at HICOG being indexed prior to shipment. Probably will arrive in one month.

For Godfrey: Will attend private showing of Russian propa- ganda films. If felt desirable, are funds available for purchasing seven reels 35 mm film for approx \$350.00 and wld such an amt be excessive and available monthly on a continu- ing basis? If so, what procedure should be used to clinch such an opportunity?

Notify J. M. Andrews that cooperation is outstanding. Immed need exists for arrival team captain soonest possible for orientation in detailed field operations.

Will proceed Paris Brussels The Hague Sunday.

The highlights of this telegram could be summarized as follows:

- The High Commissioner to Germany, John McCloy, was working with the US Secretary of State.
- A “*mutual program*” was being arranged by McCloy’s records management personnel, and other European contacts, and they were inviting input from the US Secretary of State.
- Russian propa ganda films had been prepared and were on their way.
- J. M. Andrews was the Prime Minister of North Ireland during 1940 – 1943, but he was being honored for his “*outstanding*” co-operation, in whatever role he was playing in 1951.

- Agencies in Paris (France), Brussels (Belgium) and The Hague (Netherlands) appear to have also been involved, to some extent.
- The six boxes containing the Osenberg Files were received from someone named "Norstrom".

Given the significance of the Osenberg Files to Operation Paperclip, we were intrigued to find out who "Norstrom" was. This was no easy task; however, CIA archives did provide a useful lead.

Arthur J. Norstrom was in place at the FBI in 1944, as evidenced within a declassified CIA file, which included a memo he had made. His role in the FBI also extended well beyond 1951, as confirmed by his obituary.

The screen shots of both records are set out below:

Arthur J. Norstrom FBI Special Agent Arthur J. Norstrom, 90, a retired Federal Bureau of Investigation special agent who also served as a regional director of security for Pan American World Airways, died of a heart attack Feb. 18 at the Powhatan Nursing Home in Falls Church. Mr. Norstrom, who joined the FBI in 1934, was a native of Minneapolis and a graduate of the University of Minnesota and its law school. He was assigned to FBI field offices in six states. He also was posted in the office of the legal attache of the U.S. Embassy in Tokyo and served two tours at FBI headquarters in Washington. After his retirement from the FBI in 1959, he worked about 15 years for Pan American World Airways' security management operations in Asia and New York.

Operation Paperclip was not an isolated CIA operation. It was the FBI who gave the 'Osenberg List' files to High Commissioner, John McCloy, for shipment to the US Department of State. The Telegram noted that a media propaganda operation was also underway.

Part 1 revealed that McCloy was a trusted member of the Rockefeller banking regime, and a member of the "council of trustees." The monopolists were wielding incredible power during this time in history.

A Return to the Teutonic Empire:

Is it possible that the monopolists and oligarchs were coordinating alliances and the propaganda being foisted upon the world during WW2?

We can find some clues by looking at the origins of the North Atlantic Treaty Organization (NATO), and a man named Jean Monnet:

The Dollar's Travelling Salesman

When the organizers of the North Atlantic Union decided to place a war-industrial base under it, and under the army of mercenaries of the dollar, planned on the basis of this union, Jean Monnet was entrusted with the task of "selling" this idea to public opinion in France, and with its realization.

The choice was far from being just chance. A Frenchman by birth, Jean Monnet is a typical businessman-cosmopolite. He is well known on all the exchanges of the capitalist world — not without reason did the reactionary American magazine Life call him "a citizen of France, London, New York, and Washington."

The cognac manufacturer, having traveled over half the world at one time in search of markets for the sale of products from his firm, had, at the same time, much experience in diplomatic activity; he was deputy to the General Secretary of the League of Nations, in 1939 headed the French Purchasing Mission in Washington, and later served as chairman of the so-called Anglo-French Coordinating Committee in 1939-1940, during the black months for France. Finally, the reputation of international banker was firmly attached to him, since he had learned in the minutest details all the stratagems of international transactions and calculations. Monnet had close connections with the banking house of Kuhn, Loeb, and Co. on Wall Street, with John McCloy of the Rockefeller bank Chase Manhattan, with the largest banking house of the USA, the Bank of America, which belongs to the Giannini family.

Jean Monnet oversaw the propaganda machine that would ensure NATO was established on a "war-industrial base". This would essentially place member nations on a continual war-footing, and allow for alliances to form within the intelligence agencies.

Incredibly, Monnet also had close connections to John McCloy and the Rockefeller banking corporation. LIFE magazine referred to him as "a citizen of France, London, New York and Washington." Could this reference have been one of the earliest public references to a "global citizen"?

The large banking families were connected to Monnet during the war, and involved in the trials taking place after the war. As we return our attention to the Nuremberg Trials, recall that the big brass at the trials, were US General, Lucius Clay and High Commissioner John McCloy. We showed in Part 1 that Lucius Clay confirmed the

comprehensiveness of evidence, while McCloy chose to exonerate. The two men appeared to be at odds, but let's see what the CIA knew about these two:

Immediately after the defeat of the Hitlerites in West Germany, emissaries of the largest American and British monopolies rushed in. After hastily putting on military uniforms and diplomatic dinner jackets, they took matters into their own hands. General Lucius Clay was made the first American High Commissioner in West Germany; he was Chairman of the Board of Directors of the Continental Can Company and a Director of the copper-mining company Newmont Mining.

The former American High Commissioner John McCloy was a henchman of the American financial oligarchy, especially the Rockefeller-controlled Chase National Bank (now the Chase Manhattan Bank). These people, according to the author of the pamphlet "Diary of democracy," H. A. Toulmin, "preserved and protected" the pre-war cartels. In general, as was pointed out in the pamphlet published in Great Britain in March, 1954, Who Controls West German Industry?, "the restoration of German industry was chiefly financed by American funds and through the same people as in the 1920's."

The henchmen of the Morgan monopolies take active part in subversive diversionary activity directed against the countries of the camp of peace, democracy and socialism. One of the organizers of the notorious committee "Crusade for Freedom," on which the radio transmitters of the "Voice of Free Europe" relies for support, was the not-known General Lucius Clay, president of Morgan's Continental Can Company.

Were John McCloy and Lucius Clay working for the same group of monopolists? This CIA report even refers to them as "henchmen" of the financial oligarchs! They go on to record that they "preserved and protected the pre-war cartels." McCloy worked for Rockefeller's Chase Manhattan Bank, and Gen. Lucius Clay was the President of a J.P. Morgan manufacturing company.

Finally, we note that the monopolists were referred to as "emissaries", almost as though they were conducting world-wide diplomatic missions.

In our article [Not Since 1917 – Part 6](#) we exposed that one of Hitler's financiers was German industrialist, Fritz Thyssen, who had significant corporate ties with the Bush family:

Another elusive case of reported financing of Hitler is that of Fritz Thyssen, the German steel magnate who associated himself with the Nazi movement in the early 20s. When interrogated in 1945 under Project Dustbin,¹¹ Thyssen recalled that he was approached in 1923 by General Ludendorf at the time of French evacuation of the Ruhr. Shortly after this meeting Thyssen was introduced to Hitler and provided funds for the Nazis through General Ludendorf.

This 2004 article below provides a fantastic summary of the players involved. This detail only became available after two holocaust survivors took on the Bush family. Their case allowed the media to finally reveal Prescott Bush's connection to Skull and Bones, and other significant German families at this time in history. The relationship between the US leaders and German industrialists was finally being dragged into the light:

Remarkably, little of Bush's dealings with Germany has received public scrutiny, partly because of the secret status of the documentation involving him. But now the multibillion dollar legal action for damages by two Holocaust survivors against the Bush family, and the imminent publication of three books on the subject are threatening to make Prescott Bush's business history an uncomfortable issue for his grandson, George W, as he seeks re-election.

While there is no suggestion that Prescott Bush was sympathetic to the Nazi cause, the documents reveal that the firm he worked for, Brown Brothers Harriman (BBH), acted as a US base for the German industrialist, Fritz Thyssen, who helped finance Hitler in the 1930s before falling out with him at the end of the decade. The Guardian has seen evidence that shows Bush was the director of the New York-based Union Banking Corporation (UBC) that represented Thyssen's US interests and he continued to work for the bank after America entered the war.

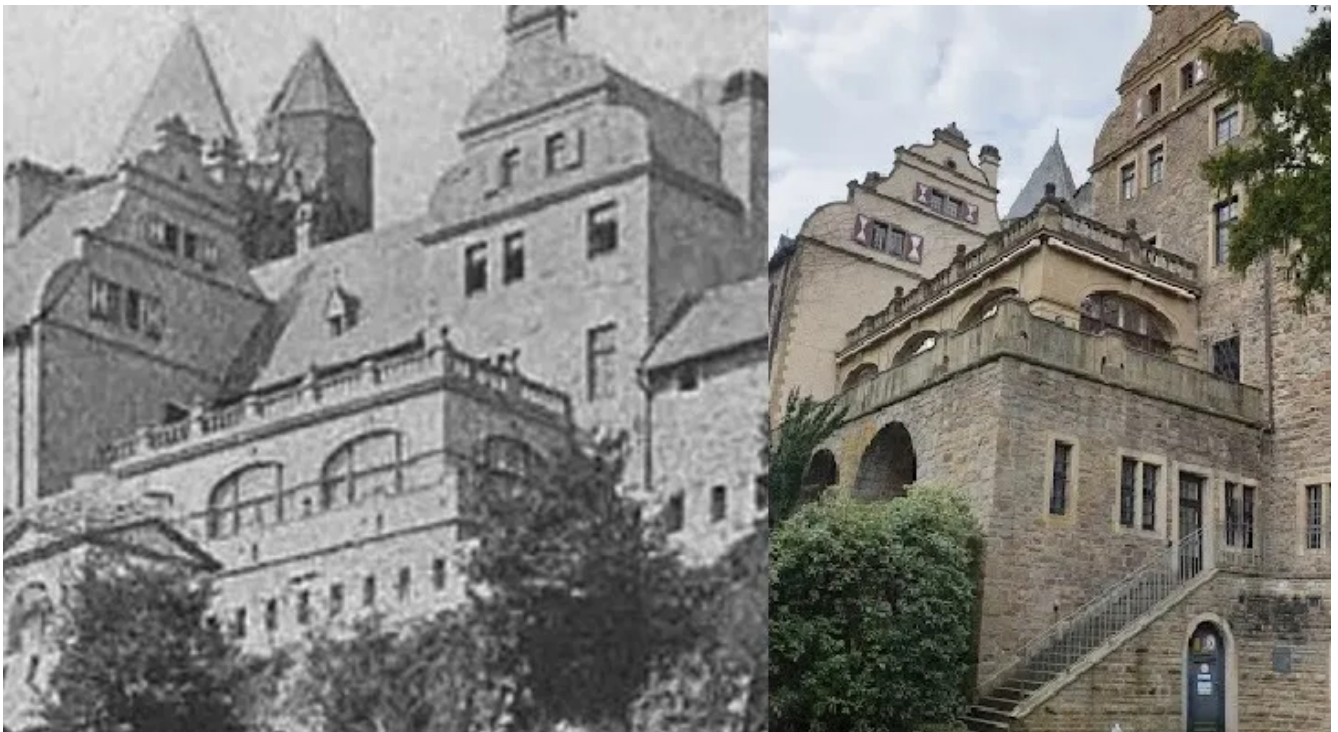
We introduce the Thyssen family at this point of our story for a specific reason, but before we reveal why, let's take a moment to admire the Thyssen's humble home – Landsberg Castle:

The above picture is from 1904, and below is an image of Thyssen's castle today, along with a side-by-side comparison.

While this tyrannical regime was infiltrating the US government, it appears that they had not yet finished oppressing Germany. In what can best be described as a 'Davos-style' meeting in Germany on 8 February 1953, these non-elected global monopolists were plotting to further enslave the German people:

Not long ago, industrial and financial magnates arrived from all over West Germany at Landsberg Castle, near Mulheim (Ruhr), which belongs to the Thyssens, a dynasty of Ruhr steel kings. It was also attended by former Hitler "leaders of military economics" -- Wehrwirtschaftsfuehrer -- and representatives of the Bonn government headed by Dr. Lehr, at that time occupying the post of Minister of Internal Affairs. Over two hundred guests assembled at Landsberg Castle.

The events which developed after the gathering at Landsberg show that this time a plot was again hatched against the German people and their vital interests. The rebirth of the Wehrmacht and the general staff of this wasp's nest of Prussian militarism, the banning of the Communist Party of Germany, the persecution of democratic forces, wild plans for establishing a "Teutonic Empire" from the Straits of Dover to the Urals - such are the new stages on the old route which the myth-makers of the twentieth century are dreaming of taking again.

The above paragraph referencing "*Prussian militarism*" was a significant find for us, because it confirmed the entire premise of #PrussiaGate, whereby an invisible army exists that controls nations. Paraphrased, this statement by the CIA could be reworded as follows:

The "*leaders of military economics*" had rebirthed a standing army (Wehrmacht) which was committed to "*Prussian militarism*", and a desire to continue the ways of the "*Teutonic Empire*", which represent "*new stages on the old route.*"

The Prussian leaders were planning further military control of Germany, as a 'new expression' on an old route.

For context, the militant regime which we refer to as Prussia or the 'horrible invisible enemy', emerged by this name when the House of Hohenzollern began to finance the

Order of the Teutonic Knights who were subduing the lands of Prussia, centuries ago. This became a formidable military force in parts of Europe at this time. This contextualizes the above reference to re-establishing a “*new stage*” for the Teutonic Empire.

Were the same industrialists coordinating a similar transition of power in the US, under Roosevelt’s Presidency during 1933 – 1945?

In a previous book, *Wall Street and the Bolshevik Revolution*, the author identified the role of General Electric in the Bolshevik Revolution and the geographic location of American participants as at 120 Broadway, New York City; the executive offices of General Electric were also at 120 Broadway. When Franklin Delano Roosevelt was working in Wall Street, his address was also 120 Broadway. In fact, Georgia Warm Springs Foundation, the FDR Foundation, was located at 120 Broadway. The prominent financial backer of an early Roosevelt Wall Street venture from 120 Broadway was Gerard Swope of General Electric. And it was “Swope's Plan” that became Roosevelt's New Deal — the fascist plan that Herbert Hoover was unwilling to foist on the United States. In brief, both Hitler's New Order and Roosevelt's New Deal were backed by the same industrialists and in content were quite similar — i.e., they were both plans for a corporate state.

There were then both corporate and individual bridges between FDR,s America and Hitler's Germany. The first bridge was the American I.G. Farben, American affiliate of I.G. Farben, the largest German corporation. On the board of American I.G. sat Paul Warburg, of the Bank of Manhattan and the Federal Reserve Bank of New York. The second bridge was between International General' Electric, a wholly owned subsidiary of General Electric Company and its partly owned affiliate in Germany, A.E.G. Gerard Swope, who formulated FDR's New Deal, was chairman of I.G.E. and on the board of A.E.G. The third “bridge” was between Standard Oil of New Jersey and Vacuum Oil and its wholly owned German subsidiary, Deutsche-Amerikanische Gesellschaft. The chairman of Standard Oil of New Jersey was Walter Teagle, of the Federal Reserve Bank of New York. He was a trustee of Franklin Delano Roosevelt's Georgia Warm Springs Foundation and appointed by FDR to a key administrative post in the National Recovery Administration.

These corporations were deeply involved in both the promotion of Roosevelt's New Deal and the construction of the military power of Nazi Germany. Putzi Hanfstaengl's role in the early days, up to the mid-1930s anyway, was an informal link between the Nazi elite and the White House. After the mid-1930s, when the world was set on the course for war, Putzi's importance declined — while American Big Business continued to be represented through such intermediaries as Baron Kurt von Schroder attorney Westrick, and membership in Himmler's Circle of Friends.

The above connections were supported by The American Chronicle:

Regrettably, the Congressional committees did not explore an even more ominous aspect of this Standard Oil — I.G. Farben collusion: that at this time directors of Standard Oil of New Jersey had not only strategic warfare affiliations to I.G. Farben, but had other links with Hitler's Germany — even to the extent of contributing, through German subsidiary companies, to Heinrich Himmler's personal fund and with membership in Himmler's Circle of Friends as late as 1944.

Legion:

Researching the CIA's references to the "*council of the gods*" led us to an executive leadership entity within the US called "*Legion*". Confirming a suspicion that the "*council of the gods*" may have expanded beyond Germany, the CIA report revealed the name of the "*council of the gods*", now operating inside the United States:

The peace movement has grown immeasurably. And no matter how heavy the pressures exerted by the Legion top echelon, its rank-and-file members still attempt to express their views on peace. And this desire is so strong that the middle level of Legion command, the heads of the posts and divisions, can no longer ignore it. The peaceful mood of the masses even penetrates the sessions of the national convention, meeting annually at luxurious resorts far from the homeless veterans, and the sessions of the Legion's executive committee which take place under the direct control of the "council of gods" of capitalist America, the National Association of Manufacturers. Here is an interesting case which enables one to understand how the Legion heads react to any stream of fresh wind bearing the breath of peace, which seems terrible to them.

The CIA report notes the "*National Association of Manufacturers*" (NAM) were now operating as the "*council of the gods*."

Is "*Legion*" a reference to an army embedded within a foreign nation? Why is their management structure known as "*Legion command*"?

The CIA report suggests that the "*middle level of Legion command*" may have been trying to advocate for peace. Notwithstanding their advocacy, any talk of peace "*seems terrible*" to the Legion heads. Are Legion the prophets of war? Are they the profits of war?

Is it possible that these crony-industrialists have literally been keeping the entire world on a constant war footing since WW2?

RIIA = CFR

The Royal Institute for Economic Affairs and the Council on Foreign Relations:

"The first two groups created by the Round Table were the British Royal Institute for International Affairs (RIIA) in 1920 and the American Council on Foreign Relations (CFR) in 1921. In fact the original plans for both were drawn up during the Paris Peace conference of 1919.

Though they were given different names to mask their autonomy, the RIIA and CFR are just sub-branches of the RhodesMilner Round Table.

"At the end of the war of 1914 [World War 1], it became clear that the organization of this system [the Round Table] had to be greatly extended ... This front organization, called the Royal Institute of International Affairs, had as its nucleus in each area the existing submerged Round Table Group. In New York it was known as the Council on Foreign Relations, and was a front for J. P. Morgan and Company."

"Later the plan was changed to create an ostensible autonomy because, 'it seemed unwise to set up a single institute with branches.' It had to be made to appear that the C.F.R. in America, and the R.I.I.A. in Britain, were really independent bodies, lest the American public become aware the C.F.R. was in fact a subsidiary of the Round Table Group and react in patriotic fury. This is the group which designed the United Nations the first major successful step on the road to a World Superstate."
