This series follows on from our last article, [Shiny Toys, KlownShows and the War for Happiness](#), which introduced the idea that enlightened despotism is playing an enormous part in what is taking place on earth at this time in history. We showed how the US Constitution offers the people the joint pathways of *life* and *liberty*, which are endowed by our Creator, through which they have the right to pursue their own happiness – however they choose. We went on to demonstrate how Enlightened Despots claim to be in the light, and if there is no obvious disagreement by the people, these self-appointed leaders regard their subjects as remaining in darkness, or ignorance.

This series will focus on Enlightened *Scientific* Despots. We will explore how the humble scientist came to have such a significant influence on the entire human experience. In our series, “Council of the gods” we investigated the origins of Operation Paperclip, and the role of the US Military offering clemency to certain Nazi war criminals. In this series we will focus on what transpired after the Paperclip Nazi scientists arrived. We will show that Paperclip was much broader than just a scientific research program to stay ahead of the Russians. Rather, it was a coordinated program of experiments aimed at advancing bio-weapons and mind-control capabilities. This series will look at the role the US central intelligence agency played in these experiments, and how this research would eventually transition over to the private sector, and into a few other unlikely places.

## Straight to work:

Whether the Nazi scientists began arriving in the US immediately after WW2 or after the [last Nuremberg Trial in April 1949](#), doesn't overly matter. Whatever the case, it

seems that inhumane tests had already been planned for the US, and they were ready to be deployed. We start this series with some startling evidence that San Francisco and New York were subjected to secret CIA-Army biological weapons experiments in 1950 and 1956 respectively:

The Central Intelligence Agency conducted five consecutive days of covert biological warfare experiments in the New York City area in 1956 with the cooperation of U.S. Army personnel.

This and other previously unknown biological tests were discovered during a four month investigation of CIA documents previously released under the Freedom of Information Act. The following is the first part of what researchers for American Citizens for Honesty in Government, an arm of the Church of Scientology, discovered. —Editor.

For six consecutive days in 1950, a U.S. Navy ship cruised off the coast of San Francisco, exposing over 800,000 people in the Bay Area to a daily cloud of bacteria.

Shortly after the tests, doctors south of San Francisco noted an unusual incidence of pneumonia among some of their Palo Alto patients, one of whom subsequently died.

While these experiments now exist deep in the annals of history, wouldn't they still constitute crimes against the US people? Furthermore, has this embedded enemy disappeared over time, or are they still present?

Fort Detrick was central to the CIA's experiments, and the CIA was working really hard to keep it all secret:

The material was found in a previously released CIA file. Among the most heavily censored of any released by the Agency under the Freedom of Information Act, the material consists almost entirely of receipts of activities and purchases made with CIA funds. According to a May 12, 1955 memo found in the file, the money was being spent to support CIA activities being carried out with a unit at Fort Detrick, Maryland. The receipts stem from a petty cash fund used by the CIA-Army team. Some receipts are marked "emergency" to indicate that such goods could not be procured quickly enough with the regular fund, and the petty cash float, which averaged only a few hundred dollars, had to be relied upon.

CIA censors had sought to delete every reference that could identify the location of the test team. In some cases, the names of firms that had printed the actual receipt form had been struck out by overzealous censors.

However, New York City was identified as the hub of the 1956 test through a \$1.50 receipt for an "Observatory fee, empire state" (sic) for "weather data" during the five day test.

Could it be that the arriving Nazi scientists were being inserted directly into existing operations?

For reference, "SOD" in the screen shot below is a reference to the US Army's Special Operations Division:

## MKNAOMI

In 1952, a secret agreement was reached between the CIA and the SOD at Fort Detrick, Maryland. The SOD was to assist the CIA in secretly developing, testing, and maintaining biological agents and delivery systems. The CIA code named the cooperative effort "MKNAOMI."

According to a 1975 report of the Senate Intelligence Committee, it is "fair to conclude from the types of weapons developed for the CIA, and from the extreme security associated with MKNAOMI, that the possibility of first use of biological weapons by the CIA was contemplated."

The SOD also researched "the possibilities of large-scale covert use of biological weapons." But, "so far as the Committee was able to determine," the capability was "never tapped by Army or CIA."

MKNAOMI was the name given to the CIA's bioweapons program. The CIA's own archives record these earliest MKNAOMI experiments, although not yet by their MK code-name. This release not only corroborates the CIA's involvement with the SOD, but provides some chilling detail around the types of things that may have been going on there:

### CIA Relationships with SOD.

The CIA relationship with SOD was formally established in May 1952 through a memorandum of agreement with the Army Chief Chemical Officer for the performance of certain research and development in the laboratory facilities of the Special Operations Division of the Army Biological Laboratory at Fort Detrick. The animus for establishing this relationship seems to have been a belief in OTS that the special capabilities of the Fort Detrick group and its access to biological materials of all sorts provided the Agency with expertise and capabilities which were appropriate to its function and not otherwise available.

MKNAOMI was a cousin to MKULTRA, and Fort Detrick was involved up to its eyeballs. By the early 1970s people were becoming aware of these programs, and were calling for accountability. In 1975, the Church Committee started looking at CIA spying operations on US citizens. This Inquiry was dramatically expanded in 1977:

While the Senate Intelligence Committee was advised that the capabilities amassed at Fort Detrick were “*never tapped*”, one is now compelled to ask - did the CIA ever really shut down these operations?

These 1975 commissions of enquiry did produce some fruit, although the public never really became aware of the breadth of the operation. The obscure CIA file that we provided above, was within a ‘Record Series’ which carried a very intriguing title. Could the title of this Series provide a glimpse into the scale of what was happening here?

Were these biological experiments somehow related to the JFK assassination? Was there something more to these mind-control experiments?

## A war against the people:

With all that we revealed in our series, “Council of the gods”, it is reasonable to assert that the CIA was comprehensively controlled by the invisible enemy at this point. This meant that a whistleblower would be required to bring any kind of truth into the light:

## SUMMARY REPORT ON CIA INVESTIGATION OF MKNAOMI

Project Discovery.

The initial identification of the relationship between the CIA and the Army Biological Laboratory at Fort Detrick as a possible questionable activity requiring further investigation occurred in late April of this year. It resulted from information provided by a CIA officer not directly associated with the project in response to the repetitive appeals of the DCI that all past activities which might now be considered questionable be brought to the attention of Agency management. As a result of the information provided by him and by two other officers identified as having some awareness of the project, it became clear that further investigation of the matter was in order.

The whistleblower suggested that Bio-weapons (BW) activity at Detrick had *not* ceased as the government had been told:

Concern about these assertions was heightened because the A/DDS&T had noted in a recent review of the 1963 IG Survey of the Technical Services Division (TSD) that approximately \$90,000 in that current fiscal year was spent at Fort Detrick "for the maintenance of a BW capability". This statement appeared so important that a quick check was made to determine its significance.

The Office of Technical Service (OTS) replied, suggesting it was doing a few small things in relation to Bio-weapons, but nothing of the scale that was reported in the IG report. The whistleblower's testimony reopened this entire narrative, and the CIA's coverup was gradually being exposed:

When new and more disturbing information about the nature of the Fort Detrick activity emerged, however, the words of the IG Survey tended to give it credibility. Thus, late in April 1975 a search was begun for any records or other information available on the project. Difficulties were immediately encountered because the project cryptonym could not be identified. The search for records of fund transfers to Fort Detrick did ultimately produce information in that regard, however, and checks by the Office of Security on one of the individuals identified as having been involved in Fort Detrick activities did provide the MKNAOMI cryptonym. This enabled OTS to recall the proper files from Records Center; two MKNAOMI files were retrieved. Some additional information was also produced from the Office of Logistics files.

The most-shocking thing about these revelations is the government's ongoing commitment to deception and non-disclosure!

This collection of material largely confirmed the nature of the project as reported by the informants and identified a number of people involved in the activity. Additional cause for concern resulted from the association of several of these people with specific assassinatic plans as revealed in the IG's report on that activity.

A major concern after the discovery of the records involved the disposition of a stockpile of BW agents and toxins maintained by Fort Detrick for possible Agency use. It was not known whether or not these materials had been destroyed along with the Army's BW stockpiles in response to Presidential Directives of November 1969 and February 1970. An unsigned memo raising the question of the disposition of Agency materials maintained by Fort Detrick posed the option of having it stored in a commercial laboratory. It was the impression of those in OTS who were familiar with the project that the material had in fact been destroyed but no records confirming it could be found.

No written records were kept. Though some CIA-originated documents have been found in the project files, it is clear that only a very limited documentation of activities took place. No records on such things as material control, receipt, delivery, destruction, etc. can be found. No documents relating to any possible operational use of the material have been found.

For the people of any nation to continue to agree to this covert government behavior, they must believe in the idea of an ongoing threat; they must believe that the government is working in their interests, in order to be more powerful than their enemies. Creating the belief in a threat is how the system of Enlightened Despotism maintains its control. The people willingly give their permission.

When it comes to the surveillance of nations, nothing much has changed since WW2. Under the guise of National Security, many state secrets remain under lock and key. Whatever the public does find out, is often fifty years after the fact, and usually after the key players have all died. This pattern of espionage-disclosure continually has people accepting that government needs to be hiding things from us.

In this same pattern of disclosure, we are only now able to find the CIA's intentions behind MKNAOMI:

### 3. MKNAOMI

MKNAOMI was another major CIA program in this area. In 1967, the CIA summarized the purposes of MKNAOMI:

(a) To provide for a covert support base to meet clandestine operational requirements.

(b) To stockpile severely incapacitating and lethal materials for the specific use of TSD [Technical Services Division].

(c) To maintain in operational readiness special and unique items for the dissemination of biological and chemical materials.

(d) To provide for the required surveillance, testing, upgrading, and evaluation of materials and items in order to assure absence of defects and complete predictability of results to be expected under operational conditions.\*

Under an agreement reached with the Army in 1952, the Special Operations Division (SOD) at Fort Detrick was to assist CIA in developing, testing, and maintaining biological agents and delivery systems. By this agreement, CIA acquired the knowledge, skill, and facilities of the Army to develop biological weapons suited for CIA use.

Reviewing these declassified documents illuminates why Senate Inquiries were demanded in 1975! Following an agreement with the Army in 1952, the CIA had progressed from stockpiling toxic poisons, to making weaponized delivery systems. They go on to note that such bioweapons, by formal agreement, must be “*suited for CIA use*”.

Outlining the objectives of an emerging program is one thing, but did the CIA and the Special Operations Division (SOD) ever act upon them in the field?

SOD developed darts coated with biological agents and pills containing several different biological agents which could remain potent for weeks or months. SOD also developed a special gun for firing darts coated with a chemical which could allow CIA agents to incapacitate a guard dog, enter an installation secretly, and return the dog to consciousness when leaving. SOD scientists were unable to develop a similar incapacitant for humans. SOD also physically transferred to CIA personnel biological agents in "bulk" form, and delivery devices, including some containing biological agents.

In addition to the CIA's interest in biological weapons for use against humans, it also asked SOD to study use of biological agents against crops and animals. In its 1967 memorandum, the CIA stated:

Three methods and systems for carrying out a covert attack against crops and causing severe crop loss have been developed and evaluated under field conditions. This was accomplished in anticipation of a requirement which was later developed but was subsequently scrubbed just prior to putting into action.<sup>9a</sup>

Having just admitted to an "interest" in having weapons that could be used against humans, the CIA suggested they commenced plans to use these weapons against animals and crops, but these were "scrubbed". We can only speculate whether or not the CIA remained true to their word.

The following records from the CIA contains evidence of years of useless invoices and payments, however we did find a memo which confirmed the nature of the CIA program being funded:

1. Subproject 42 is to be continued for the same purposes as when originally established: to support ~~██████████~~ covert and realistic field trials of certain R and D items of interest to TSS/CD, and to maintain the physical facilities required for these trials.

2. During the past few months, arrangements have been concluded and preliminary "dry-runs" have been completed for the conduct of a larger number of more complex "field" trials. These new trials are necessitated by the production of new materials in other TSS/CD-programs, advances in the State of the Art of Delivery, and the need for better controlled "field-type" experiments. (In *mind* order to cover the added cost of this accelerated testing, the total cost of this subproject is being increased from \$6,000.00 to \$12,000.00.)

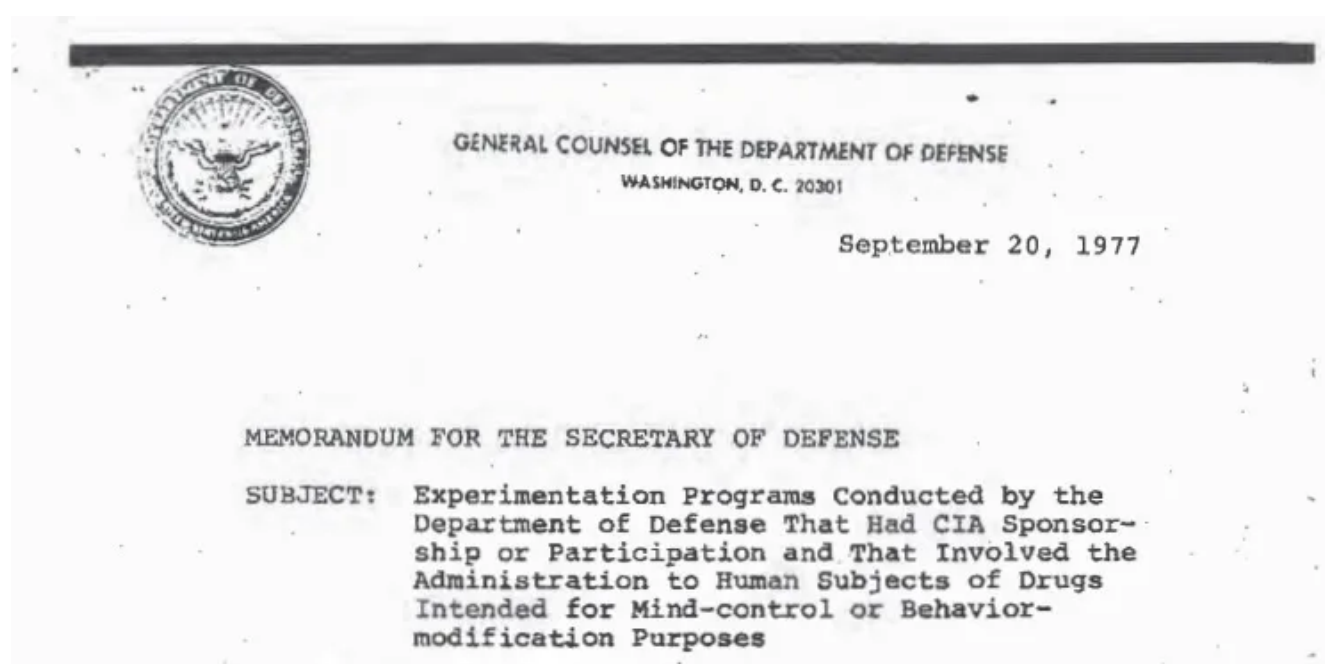
When it comes to mind-control programs, what on earth was taking place that could be described as "field trials" and "field-type experiments"? Were these field trials the ones carried out over New York and San Francisco? Were other trials going on that no-one will ever know about?

Despite President Nixon classifying toxins as bioweapons, it seemed that compliance with his order may have been sporadic:

- **MKNAOMI** was terminated in 1970. On November 25, 1969, President Nixon renounced the use of any form of biological weapons that kill or incapacitate and ordered the disposal of existing stocks of bacteriological weapons. On February 14, 1970, the President clarified the extent of his earlier order and indicated that toxins—chemicals that are not living organisms but are produced by living organisms—were considered biological weapons subject to his previous directive and were to be destroyed. Although instructed to relinquish control of material held for the CIA by SOD, a CIA scientist acquired approximately 11 grams of shellfish toxin from SOD personnel at Fort Detrick which were stored in a little-used CIA laboratory where it went undetected for five years.<sup>10</sup>

Whether other tests stopped or became more covert, we may never know. Whatever the case, the full extent of the CIA's involvement in these depraved scientific experiments was laid bare in 1977:



## I. Codeword Projects Identified by the Central Intelligence Agency

In testimony on August 3, 1977, before a joint session of the Senate Select Committee on Intelligence and the Senate Subcommittee on Health and Scientific Research, the Director of Central Intelligence reported that the Central Intelligence Agency had located a number of boxes of documents, consisting largely of financial records, relating to experiments using human subjects in which drugs were tested for mind-control and behavior-modification purposes. The Director testified that it appeared that three of the projects described by these documents -- projects designated MKSEARCH, MKOFTEN and MKCHICKWIT -- were Department of Defense programs with which the Central Intelligence Agency had had some contact. The Director also described three other projects -- designated MKULTRA, MKDELTA and MKNAOMI -- which were primarily Central Intelligence Agency projects but which might have had some Department of Defense involvement.

The above document is an incredible resource for those interested in researching the MKULTRA suite of programs. Finding this list of CIA projects allowed us to focus on what the US Army was doing in the 1970s. (1:38 mins)

One of the operations was named MKCHICKWIT. As the details of these horrible experiments come to light, the desire to slightly rename operation "McCHICK-WIT" was overwhelming!

While the 1977 Senate Committees were advised that the experiments had generally been closed, it appears that these programs simply became more and more covert.

This short video showcases Litton Bionetics, which was accused of being involved in the development of AIDS with Robert Gallo, years before AIDS was discovered. It includes an interview with Gallo, whose anger at being challenged about this possibility was obvious, showing he is a part of the enlightened despot brigade (8:36 mins):

In case this 2002 Fauci clip is ever deleted, some of the text is transcribed below:

“...so, I found myself, again, never imagining that I would be doing this; needing to learn from people that I never thought I would be learning things from; namely bioweaponers; people who were our own bioweaponers in the United States decades ago; international figures; people from other countries – the UK; and also, and importantly, defectors – particularly from the Soviet Union, who had vast experience in the ways of bio-warfare.”
